COMMENCEMENT ATTENDANCE:

PARKING: Parking is available on campus and streets surrounding the College of Law if there is not a “No Parking” sign. Please do not park on any grass area near the College of Law or campus housing. Overflow parking is located at Most Holy Name of Jesus Catholic Church, 5800 15th Avenue South, Gulfport, FL. A shuttle will run on a loop from the church to the Stetson campus continuously both prior to the ceremony start, and at the conclusion of Commencement.

GUESTS - WRISTBANDS: Wristbands are required for all guests in attendance.

- Graduates will be issued **EIGHT (8)** guest wristbands for the Commencement Ceremony.
- Guests may enter through the horseshoe, Student Center walkway, Banyan Courtyard, and the walkway on 62nd Street South between 15th and 13th Avenue South.
- Please complete the [Graduate Wristband Exchange](#) form by Friday, April 28, 2025. The Graduate Wristband Exchange form allows the Division of Student Affairs to assess the need and availability of wristbands among our students, to better assist with redistribution. The form also permits students to join a waitlist for additional wristbands if available. All students are asked to complete this form regardless of the number of wristbands they intend to use/not use for Commencement. While students may give wristbands directly to fellow graduates in need, the form submission must reflect this.

ALTERNATE SITE INFORMATION: In case of inclement weather, the Commencement ceremony will move to the alternate location, First Baptist Church, 1900 Gandy Blvd N, St. Petersburg, FL. Graduates will be advised via email as well as the College of Law homepage. If Commencement is moved to the alternative site, **the ceremony will begin at 10:00 a.m.** Graduates will need to report to the alternate site by 8:00 a.m.

If we move to the alternate site, graduates will be limited to **FOUR** guests. Guest tickets for the alternate site will be distributed during the composite photo tabling event in the Student Center on May 13 and May 14.

LEGACY: Graduates who have a family member (s) who graduated from Stetson Law with a Juris Doctor are eligible to participate in the Alumni Legacy Program and have their loved one present their diploma during the graduation ceremony. Qualifying family members include parents, grandparents, spouses, siblings, aunts/uncles, and cousins.

If you would want a qualifying family member to participate in this program, please indicate your legacy relationship when submitting your [Commencement Registration](#) and your [online permanent address form](#). You can also email the Dean's Office at lawdean@law.stetson.edu and the Development and Alumni Relations Office at tdjackso@law.stetson.edu with any questions regarding legacy participation at the graduation ceremony.

ACCESSIBILITY SERVICES: The May 2025 Commencement Ceremony will be livestreamed, with closed captions. Graduates and guests with disabilities or health concerns who may require accommodations, such as accessible seating, shall complete the information requested on the Commencement RSVP form. Graduates who request accommodations will be contacted directly by the Accessibility Resources Office prior to Commencement. Accommodation requests will be evaluated on a case-by-case basis.

REGALIA: Deadline to order regalia was February 21, 2025

All graduates will wear regalia (tam, gown, hood, cords) for Commencement.

Herff Jones will ship regalia to the Office of Career and Professional Development. Graduates will receive additional communication in late March or early April regarding regalia pick-up timelines and procedures.
